beneficial after school services including positive decision making, tutoring,  
recreation, and leadership skills. 211 children and families received daycare on a sliding fee scale,  
and families received daycare on a sliding fee scale. Approximately 402 senior citizens received home and yard maintenance  
on a sliding fee scale, chronic disease management and access to wellness clinics and personal hygiene  
products. 100 middle school students received mentor support at six middle schools  
Over 1,200 school age children will have Friday your support including  
safe supervision, food, educational, and physical activities.

Crisis Intervention Services: Over 2,043 units of service were provided. Specifically, over 790 people received disaster

Basic Needs & Financial Stability: Over 162,157 units of service were provided. Specifically, United Way funding

were provided for individuals and families experiencing homelessness.  
United Way funds provided well over 33,581 units of service for meals, food sacks, emergency  
medical prescriptions, and emergency transportation. 1,412 individuals and  
families received free tax refund assistance.

Pt III, Line 2: Pueblo Volunteer Income Tax Assistance (VITA) Program Pueblo  
VITA is an IRS program that provides free tax preparation and filing for those  
who make \$55,000 or less total household income, using highly trained community  
volunteers. During the 2019 tax season, we processed 1,412 tax refunds, resulting  
in a return on investment of over \$1,984,448 in tax returns, tax credits, and  
tax preparation savings going back into the Pueblo community. Additionally,  
1,845 volunteer hours were recorded during the 2019 tax season. United Way Mentoring  
Program United Way of Pueblo County, Pueblo School Districts 60 and 70, and  
local businesses & organizations completed our eighth year of our United Way  
Middle School Mentoring Program. At the end of our fiscal year, we had over  
100 mentors/mentees at six local middle schools, Heaton, Pueblo Academy of Arts,  
Liberty Point International, Roncalli STEM Academy Heroes Academy, and Vineland.  
The total program performance for the 2018/2019 school year showed 41% of students  
maintained or improved their GPAs, 46% had the same or less absences, and 71%  
received fewer or the same number of discipline referrals. Mentors are volunteers  
recruited from the general community as well as the business community, and spend  
one hour a week each week with their student during the lunch hour at the school.  
Mentors/mentees also attend three field trips to increase bonding and provide  
educational experiences. Students involved in the program show marked improvement  
in school engagement, grades, attendance and behavioral issues. Emergency & Special  
Funding United Way of Pueblo County helped provide support to the Pueblo Poverty  
Foundation that provides meaningful incentives for 100 plus children who show  
marked improvement in reading and vocabulary. We also provided funding for the  
Everybody County Homeless Ministry Christmas Meal, which served over 200 individuals  
and families on Christmas day. Funding was provided to the Pueblo Rescue mission

to help provide critically needed services at the emergency cold weather shelter.

This grant helped to provide over 10,000 bed nights and service to 578 unduplicated individuals. Unfortunately, one of our outstanding member agencies, Southside Children's Center, was broken into, vandalized, and had multiple educational items and electronics stolen in November 2018. In response to their emergency need, the United Way of Pueblo County Board of Trustees elected to provide additional funds to help them rebuild to provide crucial services to the children and families they serve. Community Impact Funding - Since 2005, United Way Board of Trustees has provided additional grants to help solve new and emerging needs that can make the biggest impact in our community. These are grants made for programs that have not been previously funded by United Way. As a result, United Way has invested over \$550,000 to benefit new needs in this category alone. In 2018/2019, we were called to action by the shift to a four-day school week in Pueblo School District 60, and we responded by prioritizing funding for Friday youth programming to help provide services and food for students in need in both districts. This year, we were able to invest new dollars into two outstanding organizations serving this emerging need. The Boys and Girls Clubs of Pueblo County was awarded funding to launch three Friday-only sites at CSU-Pueblo, and elementary school, and First United Methodist Church. The Pueblo City-County Library District offered STEM and history classes, educational crafts, snacks, and movies for students coming to Pueblo area libraries on Fridays. Nonprofit Training and Advocacy - United Way prides itself on having high standards of excellence in the areas of governance, finance, and donor stewardship. An example is that we serve as a lead partner in the Pueblo Nonprofit Day Luncheon, which provides training, presentations from experts in the nonprofit sector, and celebrates the enormous impact nonprofits have in Pueblo County. We often partner with other local foundations to offer nonprofit training and development opportunities. We are also compliant with

Donor-designated funds are contributions specifically directed by the donor to be forwarded to other nonprofit organizations. United Way acts as an agent that collects, processes, and disburses the funds. We provide this service as a convenience to our donors.

Since it is given solely by the desire of the donor, we do not require the recipient organizations to provide us with information relative to the use and results of these contributions. In addition, due to our campaign efforts, we distributed an additional \$48,023 in nonprofit organizations that was paid directly to organizations due to our fundraising. Volunteerism United Way of Pueblo County encourages volunteerism. United Way of Pueblo County has over 665 volunteers providing over 13,000 hours of service assisting in areas such as mentoring, tax preparation, special events, allocations, finance, marketing, and fundraising, resulting in \$321,143 worth of volunteer time at the standard volunteer hourly rate of \$24.69.

We have many donors who work to encourage philanthropy and generosity within their workplace and throughout the community. We also assist other nonprofits in finding volunteers for their organization via our large support network.
