El Pomar Foundation Community Problem Solving (CPS)

• This endowment fund was established by El Pomar Foundation to address critical and emergency needs for the homeless and indigent in Pueblo County. Direct services only.

Emergency Food and Shelter Program (EFSP)

 United Way of Pueblo County administers funds on behalf of the federal Emergency Food and Shelter Program through the Department of Homeland Security to local organizations. Any 501@3 nonprofit, faith-based or local government agency that provides ongoing food and/or shelter services may apply.
