County! With your generous and dedicated support, your Pueblo County United Way had another very successful year. Our annual campaign increased again despite a very tough year and surpassed the one million dollar mark for the SEVENTH year in a row. In fact, we have increased our campaign for FOURTEEN straight years, which has never been done before in our long history, even in light of a notso-terrific economy. So I would like to take a moment to say thank you for your generosity and time throughout my service.

As a member of the Board of Trustees and the United Way Allocations Committee. I have been fortunate enough to see firsthand how your contributions made a record impact in our community. There were well over 184,000 units of service provided in 2016, funding over 25 outstanding Pueblo nonprofit organizations and over 40 different programs within those nonprofits. It's easy to get excited about these incredible numbers. because at the end of the day you are helping to make a real difference in individual lives of so many of our fellow community members. Here are just a few highlights of those community impacts:

The United Way Middle School Mentoring Program continues to

grow with an AMAZING group of 112 mentors, giving at least one hour a week of their time to 6, 7, & 8th grade students. Grades, test scores and behavior have improved significantly, as well as general "attitude" and school engagement. We are now at Heaton, Pueblo Academy of Arts, Liberty Point International in Pueblo West, Roncalli STEM Academy and Heroes Academy. With your support we are making a difference in the lives of so many of Pueblo's youth!

Our Volunteer Income Tax Assistance (VITA) program is an IRS program that trains volunteers to provide FREE income tax assistance. In addition to saving taxpayers the cost of filing their taxes, VITA works to ensure that folks are receiving beneficial tax credits like the earned income and child-care tax credit. This year, our volunteers served over 1,250 individuals with their taxes and helped return \$1.8 million dollars

back into our community!

In total, over 9,000 people participated in United Way's community activities, with over 230 workplace campaigns, over 667 volunteers, resulting in a total impact of over \$3,412,000 (campaign, other contributions, in-kind and value invested in the community).

As we close the books on such a fantastic year and look to carry the momentum forward into next year, I would like to thank my fellow Board of Trustees and all the United Way volunteers for all the hard work that went into producing these outstanding results. Finally, I would like to thank Andrea Aragon and her exceptional staff for their untiring dedication to the Pueblo Community. In over 25 years of manufacturing management, in three large corporate organizations, I have never been involved with a more cohesive and professional team. Pueblo County is very fortunate to have such a well-run United Way organization.

94th Annual Meeting & Awards Luncheon

nited Way of Pueblo County brought the community together to celebrate how bright the future can be when working together at the 94th Annual Meeting and Awards Presentation on Wednesday, May 17. US Bank Market President Kevin McCarthy led the campaign as the 2016 Campaign Chair. He announced to an anxious crowd that a total of \$1,065,675 had been raised during the campaign! The result meets and surpasses the goal set in September 2016 of \$1,065,000, becoming highest total raised to date and the recordbreaking 14th straight year the annual fundraising campaign has increased! The campaign represents a noteworthy portion of the fundraising efforts, but does not tell the whole story of the impact. In total, United Way of Pueblo County has raised over \$3.4 million dollars in continuum of care support during the 2016 campaign, including volunteer in-kind hours, in-kind gifts, leveraged funds, special grant and program dollars.

The Annual Meeting is held each year to reveal the results from the year's campaign efforts, pay tribute to the many volunteers and donors who generously give of their time and money to benefit the community and elect new Board of Trustees members and officers (see front inside cover for a list of board members and officers). Awards were given to companies who had significant gains in their campaigns and outstanding volunteers were honored (see page 5 and 12 for complete listing of award recipients). The event was sponsored by Xcel Energy. Ruben Roman, Xcel **Energy Comanche Station senior** operations manager and United Way board member, addressed the crowd and announced that the company had raised an incredible total of \$200,546.80 in employee and corporate gifts to benefit the 2016 campaign!

United Way also gave a special thank you to PCAPP Partners (Bechtel, AECOM, Battelle & GP), Southern Colorado Community Foundation, the **David & Lucile Packard Foundation, El Pomar Foundation, Temple Hoyne Buell Foundation, US Bank, Ent Credit** Union, Little Caesars Pizza, and The Pueblo Chieftain for providing matching grants that benefited the 2016 campaign. CSU-Pueblo Head Football Coach John Wristen was recognized for selecting United Way of Pueblo County as his Charity of Choice for the 2017 Colorado Coaches for Charity for the fourth year in a row! Lawrence Kochis, previous United Way of Pueblo County Campaign Director/AFL-CIO Community Liaision was applauded for his retirement on March 31 after 30 years of service with United Way of Pueblo County. Several organizations were recognized for their new campaigns, gains, efforts, and special events held throughout the year. **Loaf 'N Jug** was recognized for their in-kind donation of two \$500 gas cards given to individuals who attended a United Way campaign presentation during the fundraising year. A special recognition also acknowledged media partners. United Way of Pueblo County Board of Directors Vice Chair Rick Holmes, Bechtel & PCAPP project manager, concluded the event by expressing his gratitude to those who support the organization, noting the impact of careful donor stewardship on behalf of United Way, and welcoming himself as the 2017/2018 incoming Chairman!

Mentors spend one hour a week with their student during the school year, often around the lunch hour as well as field trips throughout the year for bonding and educational purposes. 














Golden Corral Breakfast

In addition to providing free tax preparation, VITA works to ensure everyone in the community receives all of the tax credits and deductions for which they are eligible.

Beulah Hill Fire Fund Report

United Way of Pueblo County was asked to serve as the fund manager for the Beulah Hill Fire providing oversight and administrative support. The fire began October 3, 2016, followed shortly after on October 17 by the nearby Junkins Fire. A Beulah Hill Fire Unmet Needs Committee was formed with the assistance of the State of Colorado. The committee consisted of members from the following agencies: United Way of Pueblo County, Catholic Charities of the Diocese of Pueblo, American Red Cross Southeastern Colorado, Seventh-day Adventist Disaster Response, Salvation Army Pueblo Corps, Southern Colorado Baptists Disaster Relief, and Beulah area residents.

Case management was handled by Catholic Charities. Nearly \$18,000 was put to work to help aid in the recovery of Beulah residents greatly affected by the Beulah Hill Fire and to then assist with flood mitigation and management through the Beulah Fire Protection and Ambulance District.

Our thoughts continue to be with the residents affected by this disaster on their road to recovery.
